### REPORTS, GOOD NEWS AND ANNOUNCEMENTS

Good News – The Elementary received State Recognition specific to building and district initiatives. The schools are recognized for high growth across one or more student populations. Oroville Elementary is recognized for high growth between the 2017-18 and 2018-19 school years for the following student populations: Special Education. The Elementary growth numbers are in the top 10% of the State. The State recognition is a direct result of our staff's hard work and intentional focus.

Greenhouse update — The greenhouse operation will play a big role in supporting our career development work ie. Natural Resources Center Launch Program, Ag Program, and the future farm-to-table and community garden efforts. A deposit on the greenhouse and headhouse are being processed this month.

**Facilities Projects** - Due to the economic impacts stemming from COVID-19, I suspect the likelihood of Oroville School District receiving state funds for our Modernization Project anytime in the near future is slim.

Second, the District is currently attempting to reach an Interlocal Agreement with the City

regarding our TIB project. The District would be fronting a considerable amount of capital for this project, which warrants our request for proactive measures, some shared authority and safeguards that intend to reduce overall risk. Ensuring that a half million dollars of taxpayers' money is managed well, responsibility and wisely is a profound responsibility and it comes with a strong sense of duty. This can be assured by attending to proactive processes as enclosed in this Interlocal Agreement.
